Course Description

COURSE DESCRIPTION:

PY/CM 2091 Special Topics: Co-existence and Religion. (2-credits).

This course will familiarize students with a myriad of religious traditions and groups present in Paris and will discuss how practical co-existence works in different parts of the Paris region. Through classroom discussion and lecture, students will learn about projects, both face to face and using the new media, for overcoming religious differences in the service of tolerance and understanding. In the field, students learn to observe religious settings such as mosaues, synagogues, churches and meditation groups and engage with French people working towards coexistence.

Course Learning Outcomes

General Education

GENERAL EDUCATION: The general education program at AUP consists of four requirements: Speaking the World, Modeling the World, Mapping the World, and Comparing Worlds Past and Present.

This course can be used to fulfill the *Comparing Worlds Past and Present* requirement and as such has the following learning objectives for students:

- n. To master the historical development of Judaism, Christianity and Islam, with each student focusing particularly on one of the three traditions
- n. To be able to elaborate pertinent connections between religious history and contemporary debates, conflicts and initiatives
- n. To understand the history and emergence of concepts of secularism in a comparative, situated, way that permits theoretical distance from any given notion of secular society at any particular moment
